WHEREAS, widening SR 41 through Fresno County from the City of Fresno to the Kings County line was a candidate for Measure C funding in the Original Measure C passed by the voters in 1986; and

WHEREAS, working with the California Department of Transportation (Caltrans), the Fresno County Transportation Authority (FCTA) constructed 16 miles of 4-lane freeway and expressway along this corridor; and

WHEREAS, working with Caltrans, Kings County widened SR 41 on their end out to Lemoore Air Force Base; and

WHEREAS, a 6-mile gap of SR 41 remains un-widened along this corridor within Fresno County; and

WHEREAS, increasing vehicle traffic along this corridor has created unsafe driving conditions, resulting in increased serious accidents along the un-widened gap; and

WHEREAS, the California State Transportation Agency (CALSTA), the California Transportation Commission (CTC), Caltrans, FCTA, and the Fresno Council of Governments (FCOG) have entered into discussions to develop a funding plan for the SR 41 Excelsior safety widening project to address the unimproved gap; and

WHEREAS, any commitment by the state is predicated on a significant regional commitment; and

WHEREAS, any significant regional commitments of local funding must be included in the Measure C Regional Transportation Program Tier I list; and

WHEREAS, amending the Measure C Regional Transportation Program to include the SR 41 Excelsion project requires concurrence of the FCOG and FCTA boards; and

WHEREAS, the FCTA board has requested FCOG amend the Measure C Regional Transportation Program Rural Tier I list to include the SR 41 Excelsior safety widening project and forward to them for action.
